### **Required Meter Deposit**

Meter deposits must be paid prior to the closing date to avoid interruption of water service. The required deposit amount is \$100.00 per meter for homeowners and \$250.00 per meter for renters.

## Trash and Recycle Carts Requirements for Rental Properties

The Town has implemented regulations that will require **rental properties** to obtain additional Polycarts based on the number of bedrooms to accommodate their sanitation needs. If your home falls within one of the categories below you will need to purchase additional Polycarts from the town when signing up for water and sewer service.

- 5-7 Bedrooms must have 1 additional Waste Cart
- 8-9 Bedrooms must have 2 additional Waste Carts and 1 additional Recycle Cart
- 10+ Bedrooms must have 3 additional Waste Carts and 1 additional Recycle Cart

The Town currently supplies 1 Waste and 1 Recycle Cart: therefore, property owners will be responsible for purchasing the additional carts as outlined above. The current cost for each additional household garbage cart and associated pickup will be \$116.52 per year. The cost for additional recycling carts will be \$73.74 per year. Vacation rental properties will be monitored for ordinance compliance.
